



# Memorandum of Understanding (MOU)

*between*  
***the Embassy of the Republic of Uzbekistan in the Republic of Korea***  
***and the Global Management Support Association (GMSA)***

*This Memorandum of Understanding (hereinafter referred to as the "MOU") is entered into by and between:*

***The Embassy of the Republic of Uzbekistan in the Republic of Korea*** (hereinafter referred to as the "Embassy"), located at 99, Donhwaamun-ro 11ga-gil, Jongno-gu, Seoul, Korea, represented by ***H.E. Ambassador Alisher ABDUSALOMOV***,

*and*

***The Global Management Support Association (GMSA)*** (hereinafter referred to as "GMSA"), located at 49, Duteopbawi-ro 60-gil, Yongsan-gu, Seoul, Republic of Korea, represented by ***Chairperson Chang Jung Mi***.

Collectively, the Embassy and GMSA shall hereinafter be referred to as the "Parties."

## **Article 1 [Purpose]**

The purpose of this MOU is to promote mutual understanding and friendship between the Republic of Korea and the Republic of Uzbekistan, facilitate exchanges and cooperation between business communities and institutions of both countries, and establish a foundation for joint development.

## **Article 2 [Areas of Cooperation]**

The Parties agree to cooperate in the following areas:

1. Support for economic exchange and cooperation between companies of both countries;
2. Joint discovery and implementation of projects related to trade, investment, technology transfer, and startups;
3. Co-hosting of business exchange events such as seminars, forums, exhibitions, and trade fairs;
4. Support and promotion of international activities by young and women entrepreneurs of Uzbekistan;

5. Joint planning and execution of international development cooperation projects in Uzbekistan, including ODA and international procurement;
6. Other projects and activities mutually agreed upon by both Parties.

### **Article 3 [Roles and Responsibilities]**

1. The Embassy shall support Korean companies and institutions in entering and interacting with Uzbekistan by utilizing its local network.
2. GMSA shall provide comprehensive information and opportunities to Uzbek partners by leveraging its domestic network in Korea, with particular emphasis on promoting exports of Uzbek products to the Korean market.
3. GMSA shall facilitate the participation of Korean companies in investment and joint-venture projects in Uzbekistan by providing them with timely and reliable information on trade, investment, and partnership opportunities.
4. Both Parties shall collaborate based on mutual respect and trust and will discuss cooperation methods through regular or ad-hoc meetings.

### **Article 4 [Costs and Implementation]**

Each Party shall determine the costs necessary for implementing cooperative projects through mutual consultation, and the execution of specific projects shall be agreed upon in separate agreements or documents.

### **Article 5 [Term and Termination]**

1. This MOU shall be valid for three (3) years from the date of signing and shall be automatically extended upon mutual written agreement.
2. Either Party may terminate this MOU with thirty (30) days prior written notice to the other Party.

### **Article 6 [Miscellaneous]**

1. This MOU shall be implemented in good faith by both Parties and is intended to provide a framework for cooperation without legal binding force.
2. Any matters not specified in this MOU shall be determined through mutual consultation.


This MOU is signed on September 3, 2025 in Seoul city and prepared in English in two (2) copies, with each Party retaining one (1) copy.
